Feedback is collected manually. There are three formats of feedback forms. a. Feedback form of Teaching Learning. b. Feedback form of Institutional Performance c. Feedback form of Library There is a set mechanism of the distribution and collection of feedback forms through IQAC. Teaching learning Feedback forms are analysed by the IQAC and a collective report is submitted to the principal for the enhancement of the teaching learning process. Based on this feedback analysis general instructions are given by the Principal in the regular faculty meeting for the quality enhancement in the overall performance if required the teacher is individually guided and instructed for improvement. Mentorship programme is meant for students of I year of BA LL.B | LL.B. The purpose is to encourage students to work towards excellence and facilitate communication with the Teachers. It helps students understand the college mechanism, ethos, culture of the institution. It intends to be a medium to facilitate all round development of the students. Students of V BA LL.B and III LL.B along with the respective faculty act as mentors. The Mentors guide students for various cocurricular and extracurricular activities of the college. It begins with the induction programme. Within two weeks of the first semester, induction programme is organised for the 1st year B.A. LL.B. and 1st year LL.B. Students. Principal of the College addresses the fresher's and give them the basic information about the Course ,its relevance in the contemporary society as well as the career opportunities after completing the graduation. The students of first year are given an orientation on the following: • College Rules and Regulations • Academic and Administrative Structure and Learning resources. • Institutional cultural ethos, etiquettes and mannerism. • Sports, Cultural, Creative, Curricular, Cocurricular and Extra –Curricular as well as the welfare activities pursued by the college. • Introduction and importance of subjects /courses of study selected by the students. • Awareness about college mechanisms that exists, especially the centre and departments functioning in the college. During the Induction programme students are made aware of the Councillor and the type of help the councillor can provide to the newly admitted students to overcome their language, emotional and behavioural difficulties. After the induction programme, mentor mentee groups are created by the faculty coordinator of the mentorship programme. An introductory session of respective mentor is arranged to get acquainted with the group. Under Mentorship Programme, lectures like Career guidance, Intra Moot Court Competition, Sessions for drafting and oral presentation skills, group discussions are arranged. Such sessions benefit the student's enormously. Monthly meetings are conducted to clarify doubts, academic queries, etc. This promotes feeling of oneness among students. Mentors help student successfully tackle peer pressure, take right decisions and inculcate empathy. Mentors help students to experience joy of learning and thereby pushing them an extra mile towards the journey of knowledge!

2.5.2 – Reforms initiated on Continuous Internal Evaluation(CIE) system at the institutional level (250 words)

The Internal Evaluation is conducted as per the University syllabus. From the Academic year 201718 Savitribai Phule Pune University has introduced assessment pattern of 8020. • The College would require to conduct Internal Assessment of 20 Marks as prescribed by the University. University conducts the end exam of 80 Marks. • For Internal Exam of 20 Marks Written Test is conducted as per the University guidelines. The Topics for the Test are displayed much in advance by the subject teacher. They are displayed on the notice board of respective classrooms. The said assessments are evaluated by the subject in charge. • A proper mark sheet of all the subjects, year wise, is maintained by the respective class teacher. An Internal Exam Coordinator is appointed. • Marks are manually entered by the subject in charge on the university link provided. This is done to ensure transparency. • A retest is conducted for the students who fail to secure requisite passing marks in the said examination. For PG Course the college follows the Continuous Internal Evaluation system as prescribed by University for Choice based Credit system of 5050 Pattern. Student's performance for 50 internal • Marks is evaluated through attendance

and class performance, internal tests, project reports, practical and vivavoce.

- The performance of the students in internal assessment is displayed on notice board.
- The progress of the students is assessed through interaction with them evaluation of their tutorials, home assignments and class tests, etc.
- Every individual student is informed about his progress from time to time after evaluation.
- The students are also given oral feedback on the basis of their performance in internal exams
- In the end of semester the students need to appear for end semester exams of University for 50 Marks.

I) Study Tours Field Visits: The Objective Purpose of such an Academic Visit Study Tour is to give a valued field exposure and a glimpse of Constitutional Courts so as to enflame the desire to seek the avenues of careers at the Bar and the Bench also at various other arena, to the budding young Lawyers in the making, and to impart an insight amongst the Law Students. As per the annual tradition of our esteemed College this year also our College arranged an Academic Visit Study Tour for the Final Year Students of LLB BALLB Course, to the Supreme Court of India, the Parliament of India, the Rashtrapati Bhavan, the National Human Rights Commission (NHRC) and numerous other Historic Places, Museums Monuments at Delhi including the India Gate and Indira Gandhi Memorial Museum, and this Academic Visit Study Tour was also coupled with a fun filled Sightseeing Tour to the Historic Places such as Taj Mahal at Agra, IndiaPakistan International Border at Attari (Wagah), the Golden Temple and the Jallianwala Bagh at Amritsar and also the Shopping Spree by our Students at Amritsar and Delhi at the end of the Study Tour. The Supreme Court of India Building is one of independent Indias first major buildings to be designed by an Indian Architect. We also visited the Supreme Court Museum, and there on display are the rare Artefacts, Manuscripts, old documents, and Photographs depicting the Legal Heritage of India and the growth of our Justice Delivery System, the depiction of the evolution and development of the Judiciary in India from Ancient Times to the British Colonial Period, and the development of the Federal Court and the Supreme Court through unique items of that period.

Visit to NHRC: After a succulent and delicious lunch at Gujarat Bhavan, we headed for the National Human Rights Commission Head Quarters and were greeted by the concerned official (Training Research Department) Mr. Pankaj Kumar and we were given PowerPoint Presentations on Organisational Structures and various Departments and working of NHRC, the Process Flow of each Complaint to NHRC its culmination, Repository of Data and Analysis Research for further Actions Recommendations, and we also had a very informative and interactive Session with the concerned Official (Investigation Dept), DSP Mr. I.R. Kurillose.

Visit to Parliament of India: In the morning we visited the Parliament of India and after a strict scrutiny of each individual at multiple times at each entrance points, we had an opportunity to take an informative Guided Tour of the inside of the Lok Sabha (Lower House of the Parliament), Rajya Sabha (Upper House of the Parliament) and saw the same from the Visitor's Gallery and got very interesting information from the concerned Govt.
