RULES

ACTS FOR ANALYSIS:

1. Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act, 2020;
2. The Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020;
3. The Essential Commodities (Amendment) Act, 2020

ELIGIBILITY

Students pursuing the 3 - year LL.B. course or the 5 - year integrated law course from any recognised law school/college/university within India in the academic year 2020- 21 shall be eligible to participate.

REGISTRATION AND FEES

The participants shall fill up the google form via link provided hereinbelow –

There shall be an individual participation. Maximum 2 participants are allowed to participate on behalf of any recognised law school/college/university. In the event that more than 2 participants register on behalf of one law school/college/university, the participants who submit an email from the office email id of the College/ Dean/Head or the authorised signatory of the concerned institution shall be duly registered as a valid participant for the competition on behalf of that particular institution.

Last date for registration, payment of registration fee and filling of the Google Form is **23rd May, 2021 till 5.00 p.m.**

Registration fees of **Rs. 750/- (inclusive of GST)** only is to be paid by every participant, by NEFT.

NOTE:

- Participants are advised to preserve the screenshot of successful completion of transaction as it is required to be uploaded in the registration form.
- Participants shall upload valid ID card of the College and Authorization Letter (Scan copy/Screenshot of Authorization email) from respective college authorities in the registration form.

Upon successful online submission of the duly filled Registration Form and the payment receipt, the participants shall receive an acknowledgment mail from the Organisers notifying the participant of a unique four - digit Registration Code.

After the said Registration Code has been allotted to the participant, only the said code shall be used in all future communications between the participant and the Organisers. Apart from the Registration Code, no names, logos, seals or any such symbolic or other representation which may reveal the identity of a law school/college/university are to be used in any communications with the Organisers by the participants.

CONDUCT OF THE COMPETITION

The Competition shall be conducted in an online mode on the Microsoft Teams App.

The participants shall have to submit written submission along with Power Point Presentation and shall also have to undergo the oral presentation round.

The participants have to submit the written submissions and the power point presentation in accordance with the format mentioned in the present rule sheet on or before **25th May, 2021 till 11.59 p.m.**

The details in relation to user login and links shall be provided to the respective participants after completion of all the registration formalities as prescribed by the organisers.

STRUCTURE OF THE WRITTEN SUBMISSION:

The participants shall strictly adhere to the following format;

1. Cover Page : *(to include the name of the Statutes and participant code)*
2. Colour code for cover page ;
 - o **Blue**
3. Table of Contents
4. Brief summary of law (not exceeding 350 words)
5. Abstract of Analysis (not exceeding 350 words)
6. Analysis – (not exceeding 2500 words) excluding footnotes
 - Includes sub-index of sections of analysis that you have created
 - Mandatory sub-sections that must include:
 - Introduction

 - Conclusion
7. References

FORMAT:

1. Font: Times New Roman
2. Font Size:
 - Headings: 16 or 14 Bold
 - Text: 12 with double spacing
 - Footnotes: 10 with single spacing
3. Pages must have an inch margin on all sides
4. Header at the top of the page should be in italics and as follows:

Short title of the Act, Year of the Act
5. Page numbering should be at the bottom, right hand corner of each page, preceded by a footer in italics at the bottom left
6. Footnotes must be in accordance with the Harvard Blue Book Citation Method

SUBMISSIONS

The Participants shall submit the copy of their written submissions in soft copy format.

The participants shall mail the soft copy of written submissions (PDF Format) including the power point presentations on **snflc.lrc@gmail.com** by adhering to the dates mentioned hereinbelow;

- **Last date for submission of soft copy – 25th May, 2021 (11.59 p.m.)**

VISUAL PRESENTATION RULES:

- **Time :**
 - In total, 15 minutes are available to the presenter. 10 minutes to present the analysis and 5 minutes are reserved for questions by the panel & answers by participant in Qualifying Round.
 - In total, 20 minutes are available to the presenter. 15 minutes to present the analysis and 5 minutes are reserved for questions by the panel & answers by participant in Qualifying Round.
- **Presentation Form:** Participants must present the analysis using a Power Point presentation.
- **Dress Code:** Suitable formal attire of the participant.

GENERAL RULES:

1. The language of the Competition shall be **English**.
2. The participation will be individual. **No Co-authorship** is allowed.
3. Once the analysis is submitted, **no modification** in any form will be allowed.
4. The registration will be on first come, first serve basis subject to a maximum of 25 participants.
5. Out of the total participants appearing for the Qualifying Round, top 3 scoring participants shall be qualified for the Final Round.
6. No participant shall indulge in any act of misconduct during audio - visual recording or virtual conferencing, undermining the credibility of judges or that of the competition.

7. Any act of the like nature may lead to immediate disqualification from the competition without scope of appeal.
8. No participant shall try to disclose their identity or ask the Judges of their identities, if the participant is found violating the present rule, strict actions will be taken by the Coordinators of the Competition.
9. Any behaviour of indiscipline with the Coordinators or any other staff member or student volunteer shall be dealt with strictly and may lead to immediate disqualification from the competition without any scope of appeal.
10. No participant shall ask for feedback immediately on completion of any round.
11. The organising committee reserves the right to amend, modify or repeal any of the rules if so required and as they deem appropriate.
12. Participants shall receive adequate notice of any/all such amendments or modifications to the rules.
13. Participants are expected to have a Laptop/ PC and a stable internet connection for the purpose of the oral rounds. Any technical failure on the part of the participant shall not be considered, unless expressly pardoned by the organisers.
14. During the oral rounds, the microphones of all the participants shall be muted. The participant authorised to speak shall be eligible to unmute himself/herself and address the panel.
15. No participant is allowed to use mobile phones during any of the oral rounds, for the purposes of research, phone call, texting, or any other purposes.
16. The platform will be informed beforehand; therefore, the participants must have knowledge of using the platform. Also, preliminary information related to use of app, or any other issues related to the platform would be notified to the participants in advance.
17. The Participant shall at all times during the rounds must have his/her cameras on, if in case of connectivity issues, a frame of 5 minutes will be provided to re-join. In case the problem persists, the Participant will lose his/her chance, or will be subjected to

20. These rules are not exhaustive and the Organisers reserve the right to modify/alter/ repeal any rules contain herein, for which a prior notice shall be given to the participants.
21. If anything, not covered by rules the decision of organising committee will be binding.
