	Exhibit no C	Complainant wore a <i>khaki</i> (drab light-brown colored) shirt with a tailor mark of metro Shop no 43 Cape Township written. The shirt had loops and bands on its shoulders of Police Naik. As well as Steel bands of 'Ma Po' on shoulders .two pockets to the shirt where on the right side a band of tricolor (Orange, white, green) on left side the name plate . next to the right down the left there are blood stains. And the back side of the shirt from the shoulder down to the right side there is a mark of the assault cause due to use of weapon .
	Exhibit no D	Complainant wore a khaki terrycott pant with left and right pockets with three loops on pants are visible . on the left side of the pant there are blood stains also there are blood stains on the right side loop as well as on the right pocket. Even there are blood stains on the back of the pant on both the sides left as well as right and even on the seat.

	Exhibit no E	Complainant wore a white bannyian having a mark of the manufacturing company. On the back side, by the level of the shoulder there is an assault mark with blood stains visible.
	Exhibit no F	Accused was in old full blue pant.
	Exhibit no G	Accused wore a light yellow checks full shirt.
