Guidelines for “Write for Human Rights”- Article Writing Competition, 2024:

Broad Themes for Writing:

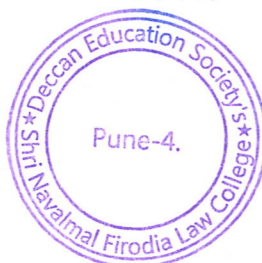
- Human Rights and International Law
- Role of United Nations Organization in Human Rights Development
- Human Rights and Indian Legal System
- Indian Judiciary and Development of Human Rights Jurisprudence
- Human Rights in Digital Era
- Impact of Artificial Intelligence on Human Rights

1. Students are expected to write an article on any of the themes mentioned above.
2. Word limit for the Article is 2000 – 2500 words. (Including Footnotes)
3. Article should be written in English Language. It should be in typed format and should be typed on A4 size paper.
4. Font for Main Text: Times New Roman, Font Size: 12, Line Spacing: 1.5.
Font for Footnotes: Times New Roman, Font Size: 10, Line Spacing: 1.
Alignment: Justified. ILI Style of Citation should be followed.
Article should be accompanied with an Abstract of not more than 300 Words.
5. Article should be free from grammatical errors and should possess structured coherence of the content.
6. Article should be an original and well researched work of the author. Plagiarism should be strictly avoided. Students are expected to acknowledge the source of references used by them while writing an Article.
7. Evaluation should be based on content, topics covered, research, analytical and writing skills, logical presentation of ideas, originality of the research work of the author.
8. Scanned PDF only of duly typed Article should be submitted on the link given below:

9. Last date of Submission of Article is 5th January, 2025.
10. Students securing First three positions will be awarded with Trophy and Certificates.
