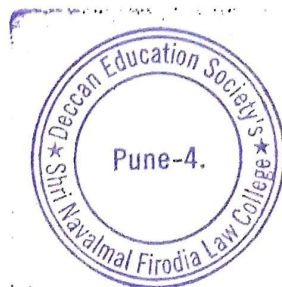
MEETING OF INTERNAL QUALITY ASSURANCE CELL

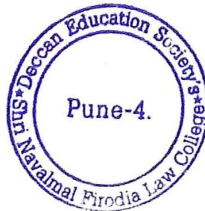

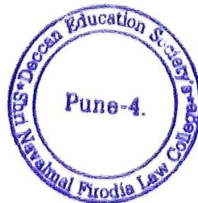

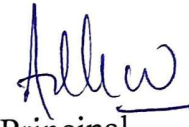
6. **Members insisted** on adhering innovative teaching methods and the integration of experiential learning.

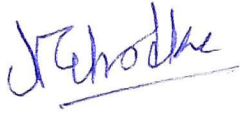
